maintenance contract for 2008.

Resolved: To accept JWC Management and Consulting's bid dated June 27, 2007 in the

amount of \$2,433.57 for repair of the wrought iron fence as long as the Association receive the 5% discount and the bid includes replacement of

missing caps and securing the remaining caps.

Resolved: To obtain additional bid from JWC Management and Consulting to paint the

wrought iron fence in addition to the repairs.

Resolved: To send a letter to Lot #149 (Netho) letting him know he will not be receiving

further letters regarding putting plants in his side yard until the guidelines have

been revised.

Resolved: To have Management take pictures of all the side yards that do not have plants.

Resolved: To register Harmon Ranch Homeowners Association with City of Chandler for
