NOVEMBER 20, 2007**

Resolved: To approve the meeting minutes of October 17, 2007, as written

Notation: The board discussed side yards that do not contain any plants. Random homeowner files were checked to see what their original landscape submittals included. The consensus was that any plant that exists should be replaced if it is removed. Each board member will send Brendan Busse his suggestions on what should be included in the landscape guidelines. Brendan will draft the guidelines from those suggestions and present it to the board at the next meeting for review.

Resolved: Management will create a Rules Document from resolutions adopted by the board that change or add any policy or defines any CC&R's.

Resolved: To have Doug Domke add the Landscape Maintenance Policy to the Website.

Resolved: Not to accept Ground Specialties' proposal dated 11/20/07 in the amount of \$6,550.00 to replace the drip system in Tract "H" at this time.

Further

Resolved: Management will obtain 3 additional proposals to replace the drip system in Tract "H" with specifications to include preserving the existing granite to cover the trenches.

Notation: A board member reported an irrigation leak in Tract "G" at the corner of Linda and Bradley on the down slop towards the grass.
